#### **Project Goals**

Goal: Automate clinical research billing to allow the enterprise to process an increased number of research patient encounters on a monthly basis without having to add additional staff.

- Reduce the turnaround time for billing entry requests to be entered from 60 to 45 days
   by August 31, 2021
- Move PB to self-pay instead of insurance billing and get research account billing to single billing office by June 8, 2021

#### Action Needed

- Confirm your research users have the appropriate Health Link access
- If Research Coordinator security is needed, training is required, and number of attendees is limited
  - Upcoming classes are 4/7 and 5/12 from 8AM-12PM
- Determine who will be responsible for two step billing review
  - Look for upcoming training
  - Billing review must be completed for studies to be invoiced

- Clinical research billing that occurs within UW Health facilities
- Research patients in the ambulatory and inpatient setting
- Cutover to use Epic method for all upcoming encounters
- Enable encounters and orders to be linked to research studies
- Collaboration with leaders within UW Health, SMPH, Carbone Cancer Center, OCT and UW Finance to ensure understanding and alignment of the work
- Training of staff to new processes
- Determine how information routes to study team to confirm research encounters and orders
- Review research tiers to ensure alignment between HB and PB to meet today's clinical research trial needs
- Incorporate two-step billing review into overall process

- Conversion of past encounters to Epic method
- Retroactive conversion of Health Link orders for research studies
- Interface of the study calendar (future phase)
- SwedishAmerican clinical research billing
